**Sub: Selection for formation of Gr.B panel of AOM/SS against 30% LDCE quota - Operating Department.**

It has been decided by the Competent Authority to hold the selection for the post of AOM/SS Group 'B' against 30% LDCE quota, in continuation to the 70% (promotion quota) selection for the assessment cycle 01.01.2021 to 30.06.2023.

**Eligibility Condition:** The Group 'C' staff of Operating department, working in Level – 6 and above in Pay Matrix with 5 years of non-fortuitous service in Level -6 and above (including non-fortuitous service rendered in the corresponding pre-revised grade pay) as on **01.01.2021** will be eligible for the said selection. (Authority: SER's Estt. Srl. No. 54/2010 and RBE No. 216/2019).

**Comparison of grades of running staff with those of stationary staff for the purpose of Promotion/selection to Gr.B posts would determined in terms of Railway Board's letter No. E(GP)2005/2/87 dated 18.08.2015 (RBE No. 92/2015).**

**NOTE: 1.** Staff whose lien is maintained in S.E.Rly is only eligible.

2. In terms of Railway Board's letter No.E (NG)I-93/PMI/4 dated 18.1.93 time spent by the railway servant under training immediately before appointment to service will be counted as service for the purpose of LDCE.

**Date of submission of application and consolidated statement:-** Willing staff, fulfilling the above conditions should submit applications as per enclosed proforma to their respective Personnel Officer through their controlling officers on or before **12.09.2021**. The concerned Personnel Officer on receipt of such applications will scrutinize the applications and send the name of eligible staff only in **consolidated statement as per proforma attached** so as to reach this office latest by **30.09.2021**. The concerned Personnel officer should ensure that all the columns of the enclosed proforma are properly filled in before sending the statement to this office. **Signature and date both are compulsory otherwise applications are liable to be rejected.**

**NOTE: Staff working on Construction/Project/Ex- Cadre Organization/Units or serving on other railway should submit application to their respective Personnel Branch Officers where they hold lien.**

Individual application of the staff concerned need not be sent to this office. It may also be noted that incomplete statements furnished by the divisions/units will not be entertained and are liable to be rejected.

**Objective and Scheme of the Examination:** The examination aims at a comprehensive assessment of knowledge of the candidates and has essentially to be a rigorous test of their professional ability.

**SCHEME OF EXAMINATION:**

A) In terms of Railway Board's letter No. E(GP)2018/2/31 dated 19.03.2019(RBE 53/2019) there will be two tier written examinations: **Pre-qualifying Examination & Main examination.**

i) **Pre-qualifying Examination** shall comprise of **one Paper** which will have **100% Objective type Multiple choice Questions** only with negative marking; one-third marks allotted for each question will be deducted for each wrong answer. The paper will be of **100 marks** and distribution will be as under:

Subject	Maximum Marks	Qualifying Marks
a. Technical Subject	40	75%
b. General Knowledge including optional Question on Official language policy	30	
c. Establishment and Financial Rules	30	

**(NOTE:** The candidates scoring 75% marks and above in the Pre-qualifying examination shall be eligible for appearing in the main examination and for this, number of candidates should be restricted to 5 times of the number of respective vacancies in order of merit, if more than required number of candidates score above the qualifying marks.)
