

Eligibility :

- (i) Staff of Personnel Department working in erstwhile Scale Rs.9300-34800/- GP Rs.4200/- ( level 6 in 7<sup>th</sup> PC) on a regular basis.
- (ii) Staff of Personnel Department working in one scale below erstwhile Scale Rs.5200-20800/-, GP Rs.2800/-ln (level 5 in 7<sup>th</sup> PC) on a regular basis.
- (iii) Staff should have completed at least five years service in Railway.
- (iv) Staff working in level 5 of 7<sup>th</sup> PC will be considered only if suitable candidate from Level-6 of 7<sup>th</sup> PC is not found suitable.
- (v) Staff who have already completed their tenure in Vigilance Organisation of Zonal Railways/ Production Units/Railway Board as Investigating Inspector ( Vig)/Vigilance Inspector are not eligible to apply.
- (vi) The staff should have sound integrity, should not be figuring in any current Vigilance /SPE/DAR case and should not have been imposed any Major/Minor penalty in any past Vigilance Case.
- (vii) Staff should have working knowledge of Computer.
- (viii) The Selection will comprise of written test and viva-voce.


