

Applicants having adequate educational Background (minimum Graduate/Degree in Tech./ Educational qualification as applicable against Direct Recruitment Quota) in relevant category, practical experience and special aptitude for safety related works should apply in the prescribed proforma enclosed herewith as Annexure-I. Full care should be taken while filling up the application proforma. Incomplete application(s) will be rejected. Application(s) duly filled in and signed by the candidate should be endorsed by the controlling officer before forwarding the same to the Divisional Personnel Branch. Divisional Personnel Dept. should certify service particulars of the staff. **Without certification of Personnel Dept., applications will not be entertained.**

The post of Safety Counsellor/GRC is an Ex-cadre post and the tenure is normally 5 Years. The lien of the selected candidate will be maintained in their Parent Division. The selected candidate may be repatriated to his parent organization before completion of the prescribed tenure if not required by the Safety Organisation.

Any employee(s) presently working in ex-cadre post is/are not eligible to apply for the subject ex-cadre posts unless he/she has completed the mandatory cooling period of 2(Two) years.

MODE OF SELECTION: - Candidates will be selected through written test, APAR of last 03(Three) Years and Scrutiny of Service Records. There will be no scope for the Supplementary Written test.


