Sub: Selection for formation of a panel of Law Officer (Group-B) for the assessment year
01.09.21 to 29.02.2024.

It has been decided by the Competent Authority to hold the selection for the post of Law Officer (Group-B) for filling up of **05 (UR) vacancies** for the assessment year 01.09.21 to 29.02.2024. To this effect 11 senior most eligible candidates, who has completed two years service as on 01.09.2021, will take part in the selection. List of candidates' may please be seen at ANNEXURE – A to this letter.

In case any candidate is on leave or on deputation to other Railways / Units or on sick list, the Controlling Officer concerned should send necessary advice to the authority under whom he/she is working or the Medical Authority, as the case may be, and an acknowledgement obtained. Concerted effort should be taken to ensure that this notice is reached to all the candidates.

SCHEME OF EXAMINATION:

A) In terms of Railway Board's letter No. E(GP)2018/2/31 dated 19.03.2019(RBE 53/2019) the written examination will comprise of one Paper which will have **100% Objective type Multiple choice Questions** with negative marking; @1/3 of the marks allotted for each question will be deducted for each wrong answer. The paper will be of **100 marks** and distribution will be as under:

i) Technical Subject including Official language policy : 70 marks

(NOTE: There will be 10 marks on Official Language Policy, which shall be optional in nature).

ii) Establishment and Financial Rules : 30 marks

iii) **Qualifying marks:** : 60 (out of 100)

The successful candidates in the written examination will be called for viva-voce test subject to being found medically fit in the prescribed medical standard. Viva-voce will consist of:


