NOTIFICATION

Sub: Selection to the Post of Safety counselor (Level 7 in 7th CPC) (Ex-cadre) of Engg. Deptt. to be operated under administrative control of DSO/RNC.

It is proposed to fill up 01 vacancy of Safety counselor (Level 7 in 7th CPC) (Ex-cadre) in Engg. Deptt of RNC Division to be operated under administrative control of DSO/RNC. Applications are invited from existing SSE/P.Way & JE/P.Way of Engg. Deptt of RNC Division who fulfill the following service conditions are called for.

- (i) Senior Section Engineer (P.Way) (level-7 in 7th CPC Matrix) and completed the minimum two years of regular service including service rendered as JE(P.Way) in case promoted from JE(P.Way).
- (ii) Junior Engineer (P.Way) (Level 6 in 7th CPC Matrix) and completed the minimum two years of regular service.

The post of Safety counselor(Engg.) is ex-cadre post and tenure is 04 years and up to maximum of (4+1)=5years.


The selection will consist of one paper in professional ability as per syllabus. For empanclment 60% marks in professional ability and 60% marks in aggregate must be obtained.

The selection will be finalized entirely on merit as per the instruction contained in RBE No. 113/2009 dtd. 19.06.2009 circulated vide Estt. Srl. No. 132/2009.

In terms of Estt. Srl. No. 73/2019 dtd. 10.04.2019 and 122/2019 dtd. 27.06.2019 to being objective to the selection process which are as follow:-

- (i) The question paper will be 100% Objective type Duration of examination will be 90 minutes.
- (ii) All the questions will be of multiple choices only.
- (iii) To ensure the authenticity of the answers, cutting overwriting erasing or alteration of any type in the answer will not be accepted. Zero Marks will be given for answer having correction/over writing.
- (iv) The examination should be either on computer based test or may conducted on OMR sheet. It clearly stipulates that the carbon copy should be kept in safe custody of officer nominated by the authority nominating the selection committee.
- (v) Railway may conduct examination in CBT mode or pen and paper depending on preparedness.


- (vi) If computer based test takes time to implement, the tests may be conducted on OMR sheets, which shall have a carbon copy, kept in safe custody of officer nominated by the authority nominating the selection committee. OMR can be evaluated manually.
- (vii) As (vii) of RBE No. 196/2018; there shall be negative marking for incorrect Answer. One third of the marks allotted for each question will be deducted for wrong answer. No negative marking against non- attempted question.
- (viii) Responsibility for evaluation shall be with the Officer nominated for evaluation.
- (ix) The system of coding & decoding of answer sheets will continue.

The question on official language will form part of the professional ability for 10% of total marks. The question on official language policy are compulsory but there shall not be any compulsion on the part of the candidates to answer such questions. (CPO/SER's Estt. Srl. No. 78/96).

The willing and eligible volunteers have to submit their applications in prescribed Performa (Enclosed at Annexure-I) to the concern Supervisor official. The controlling officer has to forward all the applications in one bunch to this Office on or before 28.02.2022. Incomplete application received after the last date will not be entertained and the same should be disposed of at the unit level rejecting them on account of late receipt. This may given wide publicity amongst the staff under your control including those who are on deputation, undergoing training, on leave/sick etc.

The employee may also note that no supplementary examination will be held under any circumstances.
