NOTIFICATION

Sub : Re-engagement of Retired Railway Supervisors on monthly remuneration basis in exigencies of service-setting of Gati Shakti Unit (GSU) of Adra Division.

In terms of Railway Board's letter No.2021/W-1/Genl/Gati Shakti dated 27.07.2022, RBE Nos.102/2022 & 112/2022 read with PCPO/SER/GRC's letter No.SER/P-HQ/Ruling/O/992 dated 18.10.2022, it has been decided to re-engage 34 (Thirty Four) Retired Railway Supervisors, who have retired from Railway Service from Adra Division, S.E. Railway, on monthly remuneration basis as prescribed in Railway Board's Letter No.E(NG)II/2007/RC-4/CORE/1 dated 24.10.2019, for operation of the following posts of Gati Shakti Unit (GSU) of Adra Division, S.E.Railway.

Therefore, applications from eligible retired railway supervisor who have retired from railway service from Adra Divisions, S.E.Railway are called for.

Supervisors retired from Adra Division, S.E.Railway desirous for re-engagement may submit their offline applications if any in the prescribed format at Annexure-'A'(copy enclosed) to Ch.OS (Cadre Management)Cell/Personnel Branch, S.E.Railway/Adra or online application over to E-Mail ID srdpoadra@gmail.com on or before 20.12.2022 at 18.00 hrs positively, thereafter no application will be entertained under any circumstances.

1. DRM/ADA is empowered to re-engage retired Railway Supervisors in exigencies of service for setting of GSU for Adra division within the overall provisions in estimates of the projects being executed by the GSU/ADA.
2. All the Railway Retired Supervisors who have not attained 64 years 06 months on the closing date of notification (to ensure at least six months service is available after re-engagement) for re-engagement purpose will be eligible.
3. The eligibility criteria for selection of supervisors will be as follows:
 - i) The Supervisor should be MEDICALLY FIT for the respective category applied for as per IRMM.
 - ii) The APARs of last 3 years immediately before retirement should be "VERY GOOD". If last three years' APARs are not available, previous three years' APARs will be considered.
4. Monthly remuneration of a retired Railway Supervisors being re-engaged will be governed in terms of Railway Board's letter no.E(NG)II/2007/RC-4/CORE/1 dated 24.10.2019 i.e., total monthly remuneration and pension drawn by the retired employee re-engaged on contract basis cannot be more than last pay drawn by him/her at current DA rates. Other terms and conditions laid down in letter dated 24.10.2019 are also applicable in this scheme.
5. The contract of the supervisors can be terminated by either side by giving one month's notice. However, in case of gross negligence/misconduct/irregularities, the engagement/contract may be terminated with immediate effect on the basis of CPO/SER/GRC's Estt.Srl.No.227/2018.
6. This scheme is valid up to attaining the age of 65 years of re-engaged employees or till further orders, whichever is earlier.
