Subject:- Review of GPWIS Policy

The GPWIS policy issued vide letter no. 2018/TC(FM)/04/01 dated 26.04.2018 along with subsequent amendments thereof have been reviewed, and Board has decided that:-

1. There will be moratorium for two (02) years for induction of 'fresh' rakes under GPWIS policy.
2. Rakes for which permission have already been granted under the scheme, would be allowed to be inducted as per the provisions of the policy.
3. Changes in the circuits of the rakes already inducted/being inducted shall be permitted as per the extent provisions of the GPWIS policy.

This is applicable with immediate effect.
