

In terms of instructions contained in this office Special Rates Circular No. 342(G)/2022 dated- 29.12.2022 Bandhdih Goods Shed [Alpha Code : BDIH, Numerical Code : 07120349] has been notified to deal with all commodities including inward and outward traffic of Coal and Coke (under priority D) upto 31.03.2023.
2. Now competent authority has accorded permission for six (06) months extension of validity for the subject goods shed (ref ii).
3. In view of the above, it is notified for information and guidance of all concerned that validity of Bandhdih Goods Shed [Alpha code : BDIH, Numerical code : 07120349] is hereby extended upto 30.09.2023 for booking of all commodities including inward and outward traffic of Coal and Coke (under priority D) subject to clearance from concerned state PCB.
