1. Please refer to Board's Rates Circular and its Addendum/Corrigenda under reference, wherein Freight Incentive Scheme for Loading of Bagged consignment in open and flat wagons was introduced w.e.f. 24.10.2016 and modified/extended from time to time.
2. The last extension upto 31.03.2023 was granted in terms of Corrigendum No. 6 to Rates Circular No. 27 of 2016 dated 16.03.2022.
3. The matter has been reviewed and it has been decided by the Competent Authority to extend the validity of the subject scheme for a further period of one year i.e. up to 31.03.2024.
4. All other terms and conditions of the Rates Circular under reference shall continue to apply unchanged.
5. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.
