1. In terms of this office Special Rates Circular SI No. 124(G)/2016 dt. 26.08.2016, Phase-I of Private Freight Terminal (PFT) of M/s CONCOR at Jharsaguda [Alpha Code: GFCJ] was commissioned with limited period of validity, subject to certain terms and conditions as contained therein and as notified from time to time through different circulars for this PFT.
2. The subject PFT has been notified for charging freight on through distance basis JSG + 3.744 km vide this office Special Rates Circular SI No. 104(G)/2020 dt.21.07.2020.
3. Based on the representation of M/s CONCOR, competent authority granted time to time extension of validity for this PFT. Latest extension was notified vide this office Special Rates Circular SI No: 188(G)/2022 dt. 22.07.2022 to remain in force upto 31.07.2023.
4. Now, competent authority has approved for extension of the aforesaid commercial notification by one (01) year. (Ref: ii)
5. It is therefore, notified for information and guidance of all concerned that, commercial functioning of the Private Freight Terminal(PFT) of M/s CONCOR at Jharsaguda [PFT code: GFCJ, Numerical code: 07221504] is hereby extended for a period of one (01) year from 1st August 2023 (i.e. to remain in force upto 31st July 2024).
6. All other terms and conditions as notified in respect of this PFT [Alpha Code: GFCJ] will remain unchanged.
7. All staff concerned to please note and ensure compliance and requisite data may be fed into the system (RBS/FOIS/TMS) wherever applicable accordingly.
