- N.B. 1) The scheme is valid upto attaining the age of 65 years of re-engage employees or till further orders whichever is earlier.  
2) Administration is at liberty to terminate the contract of the supervisors by either side by giving one month's notice. However, in case of gross negligence/misconduct/irregularities, the engagement/contract may be terminated with immediate effect on the basis of CPO/SER/GRC's Est. Sr. No. 227/2018. The retired Railway Supervisor should work on satisfaction to the administration.  
3) The monthly remuneration of a retired Railway Supervisors being re-engaged will be governed in terms of Railway Board's letter No. E(NG)/1/2007/R-C/4/CORE/1 dated 24.10.2019 i.e., total monthly remuneration and pension drawn by the retired employee re-engaged on contract basis cannot be more than Last pay drawn by him at current DA rates. Other terms and conditions laid down in the above indicated letter dtd. 24.10.2019 are also applicable to the above indicated retired staff.  
4) The Re-engaged employees will not be eligible for any kind of leave (like CL, LAP, and Sick Leave etc.) and Railway Pass/PTO and Railway accommodation etc.  
5) The Re-engaged employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.  
6) On joining to the above indicated post, it will be considered as deemed agreement to abide by all the terms and conditions for the re-engagement.  
7) You will be held responsible for the care of Government Money, goods and stores and any other property that may be entrusted to your care and the discharge of official duties. If any loss of railway property may be dealt as per extent rules.  
8) Date of joining in the above post should invariably be intimated to this office, at the earliest.
