Sub: Extension the period of validity of Commercial Notification issued in respect of the private siding of M/s Essel Mining and Industries Ltd (Appahatu) [Alpha Code: PEMJ, Numerical Code: 07221519] up to 30.09.2023.

(iii) Approval in e-office File No. SER-HQ0COMM(SDNG)/12/2020-O/o DY.CCM(FS)/ HQ /COMML /KOL / SER[Computer No: 23902] vide Note # 67 dt. 23.08.2023.

1. On approval of the competent authority, commissioning of Phase I work of the private siding of M/s Essel Mining & Industries Ltd (Appahatu) [Alpha Code: PEMJ, Numerical Code: 07221519] served by Jaroli station was notified vide this office Circular No: 233(G)/2019 dt.13.12.2019 for booking of iron ore as outward traffic subject to the terms and conditions as contained therein.
2. The validity of the aforesaid notification was extended time to time. Last such extension was issued vide this office Special Rates Circular SI No. 185(G)/2023, dt. 30.06.2023, to remain in force up to 15.08.2023 subject to the conditions that:-
 - i) before starting movement of rakes from/to this siding CKP Division shall ensure that this siding is certified technically fit and safe for continuation of rail operation and all statutory norms have been ensured for safe rail operation from/to this siding.
 - (ii) all concerned will ensure compliance with guidelines of Board for weightment of rakes booked from this siding (PEMJ) in the Associate /Alternate Associate Weighbridges (EIMWBs) as notified by Operating Department.
 - (iii) Sr.DCM/CKP to ensure submission of valid CTO by the siding owner.
 - (iv) phase-II work of the siding is done in one year from the date of issuance of this circular.
 - (v) all other conditions including that of charging freight on through distance basis as notified vide Circular No. 233(G)/2019 dt. 13.12.2019 remains unchanged.
3. Now, competent authority has accorded approval for extension of the period of validity of the aforesaid Commercial Notification up to 30.09.2023.
4. Accordingly, it is notified for information and guidance of all concerned that, validity of Special Rates Circular SI No. 185(G)/2023, dt. 30.06.2023 issued in respect of the private siding of M/s Essel Mining & Industries Ltd (Appahatu) [Alpha Code: PEMJ, Numerical Code: 07221519] will remain valid up to 30.09.2023.
5. All commercial dues accordingly may be levied.
6. All concerned are to note and act accordingly. Requisite data may be fed into the system (FOIS/RBS/TMS wherever applicable)
7. This has the approval of the Competent authority.
