Laparoscopy/Anaesthesia/Dialysis Unit/Cardiology/Endoscopy etc. )**

The earlier website notice - Part-2 B regarding registration of firms for consumable/disposable medical items/non-medicinal items/medical stores & consumables will supersede.

1. The firm should download the attached conditions and proformas and fill up as per Annexure-A, put up their signature and stamp and submit it to the Chief Medical Director, South Eastern Railway, Garden Reach, Kolkata-7000 43 along with the followings:-
  - (i) Rs.5000/- as fees for registration ( after approval from PCMD ).
  - (ii) Detailed product list in excel format. The hard copy to be submitted along with application and soft copy to be sent to the following e-mail id. – [cmdserstores@gmail.com](mailto:cmdserstores@gmail.com)
  - (iii) The application format to be as follows in Annexure.
  - (iv) Indicative product list generally required in S. E. Railway is attached.

1. The Average turnover for the past 3 years of the Marketing firms/Authorized dealers & stockiest/importers should be Rs. 50 lakhs and above.
2. The firm should submit a declaration that there was no punitive action taken against the firm by any Zonal Railway/Central Government/State Government and if the declaration is found wrong the firm can be delisted for 3 years all over Indian Railways.
3. The product should have valid Manufacturing license of manufacturer.
4. The manufacturing unit should have ISO/CE/BIS/FDA/other certificate equivalent to it.
5. All firms registered will be required to be registered with IREPS for e-tendering. IREPS.
6. Firms should give an undertaking that they will not be part of cartel with other vendors and will be quoting competitive rates in the tender. If the rate quoted by the firm in cartel they may be deleted from the list of approved vendors.
7. Firm should attach highest value Purchase order awarded to them.
