In terms of instructions contained in this office Special Rates Circular No. 84(G)/2023 dt. 29.03.2023 Bandhdih Goods Shed [Alpha Code : BDIH, Numerical Code : 07120349] has been notified to deal with all commodities including inward and outward traffic of Coal and Coke (under priority D) up to 30.09.2023.
2. Now, competent authority has accorded permission for commissioning of the subject goods shed to **work on regular basis without any time limit on validity** (ref ii).
