Srl. No. 1 to 6 above are found eligible after due verification of their representation and similar cases subject to passing of A2 medical category whenever sent for medical examination for their current medical status during the process of selection. However, out of 347 applicants, 284 candidates are found eligible and 63 candidates are found in-eligible.
