**Eligibility Criteria.**

- Candidates should be working in S & T department.
- Candidate should be from **signal wing** in Level-7 (7<sup>th</sup> PC) or one scale below i.e in Level-6(7<sup>th</sup> PC) on a regular basis.
- Candidate should have completed at least five (05) years continuous Service , as on the date of notification.
- Staff who have already completed his tenure in Vigilance organisation of Zonal Railways/Units /Railway Board as Investigating Inspector( Vig) /Vigilance Inspector is not eligible. However if they have completed sufficient cooling off period( minimum 02 years) thereafter they are also eligible to apply.
- The staff should have sound integrity , should not be figuring in any current Vigilance /SPE/DAR case and should not have been imposed any major /minor penalty in any past Vigilance case.
- Knowledge of common computer application is necessary.
- Maximum age limit of the applicant should be 55 years as on **31.10.2023**.


**Selection Procedure:-**

- a) The selection will comprise of a written test followed by a Vigilance Aptitude and computer knowledge test. The candidate who obtain at least 60% marks in the written test will be called for Vigilance Aptitude and Computer Knowledge test.
- b) These posts have been kept as tenure posts. The normal tenure of Vigilance Inspector is 03 years which could be extended upto 05 years in individual cases of special merit.

**Procedure for Submission of Application.**

- a) Applications of eligible volunteers should be duly filled up in the enclosed proforma and submitted through proper channel duly forwarded by their Controlling Officer , to the Zonal Railway /Unit Vigilance Department. The Zonal Railway/Unit /Department shall forward the applications of only eligible volunteers alongwith the current Vigilance/SPE/DAR clearance, the past Vigilance history, and last **03 years APARs** of each applicant.
- b) **The last date of receipt of applications from the Zonal Railways /Units is 12<sup>th</sup> December,2023.** The Zonal Railways /Units may ensure that the applications of eligible staff only are forwarded to the Dy Chief Vigilance Officer/S&T S.E.Railway/11,GardenReachRoad, Kolkata-700043 before the due date. **Application received after due date will not be considered under any circumstances.**
- c) It may be ensured that only the applications of eligible staff having proven integrity are forwarded. The applications received through the Zonal Railway/Units Vigilance Department will only be entertained.
- d) Vacancy circular may please be given wide publicity and should be displayed prominently on the notice board for information of the staff.
