Serial No.99/2017 to have their pay fixed under this rule from the date of such promotion or to have the pay fixed from the date of their next increment (1st July or 1<sup>st</sup> January, as the case may be) accruing in the level of the post from which they have been promoted. The said option is to be exercised within one month from the date of promotion.
